REPORT OUT: CAO, Larry Spikes stated that the Board authorized under Conference with Labor Negotiator/Meet and Confer - Unrepresented Management to appoint Rebecca Campbell as the Assistant County Administrative Officer with a salary of \$10,000 per month or \$120,000 per year effective pay period 14 on June 20, 2016.
