REPORT OUT: Larry Spikes stated that in the matter of Sacramento Superior Court Case 34-2016-00204740, entitled Tos, et at. Vs. California High Speed Rail Authority, the Board discussed the potential for litigation on October 18, 2016, in preparation for funding plan approval by CHSRA for certain "useable" segments, including in the Central Valley. On December 13, 2016, CHSRA approved two funding plans in reliance on AB 1889. That same day, a complaint for Declaratory and injunctive relief was filed on behalf of Kings County and others consistent with the Board's October 18, 2016 authorization and December 13, 2016 follow-up conversation. In the interim, a retainer agreement has been finalized concerning the prosecution of such litigation.
