Supervisor Verboon stated that he attended the Ag Valley Roundtable on March 14, 2017.

Supervisor Fagundes stated that he attended the Kids Day at the Kings Fair event and the Kings Community Action Organization meeting on March 15, 2017, attended the Kings Commission on Aging meeting on March 16, 2017, attended the Stratford seafood boil event on March 18, 2017 and attended the Kings/Tulare Area Agency on Aging meeting on March 20, 2017.

Supervisor Neves stated that he attended the CalViva Health meeting on March 16, 2017, attended the Lemoore Veteran's Hall St. Patrick's Day dinner on March 17, 2017, announced baseball at Lemoore High School, attended the Stratford seafood boil event on March 18, 2017, attended the Emergency Operation Services training and helped first responders at a traffic accident in the evening at Kent Avenue and Highway 41 on March 20, 2017.

Supervisor Valle stated that he attended a meeting on March 18, 2017 with a representative of Hansen Ranches regarding the flood control work being done in Corcoran, attended a meeting with homeowners regarding the Corcoran bypass portion of unoccupied homes which the California High Speed Rail has purchased and are now being vandalized and spoke with Diana Gomez who stated that they will now have a security guard in the area around the clock and are working with a local contractor to have the home removed. He stated that on March 16, 2017 he was in Kettleman City and reported on social media on the curb, gutters and sidewalks being installed and thanked everyone who has been working on the project.

- ♦ Board Correspondence: Rebecca Campbell stated that the Board received two letters from the U.S. Department of Agriculture that includes Kings County in the drought designations regarding available emergency farm loans from both physical and crop production losses up to \$500,000 and for small business loans for businesses that do business with growers and the application deadline is October 23, 2017. She stated that the Board received a Notice of modifications to text of proposed changes in the regulations pertaining to pesticide use near school sites from the Department of Pesticide Regulations and comments are due by April 4, 2017 at 5:00 p.m. She stated that the Board received a letter from West Hills Community College District stating that they adopted a resolution approving rescheduling of governing board elections from odd-numbered years to even-numbered years starting in November 2018. She stated that the County of Kings received a "Certificate of Excellence in Financial Reporting" from the National Government Finance Officers Association for the first time since 1998, and thanked Becky Valenzuela and Liz Cruz for their efforts on the County's Annual Financial Report.
- ♦ Upcoming Events: Rebecca Campbell stated that the Kings County Employee Recognition Barbecue will be held on May 2, 2017, the Color Me Green Run hosted by Kings County 4-H on May 7, 2017 at Hickey Park, the Sheriff's Posse will hold their annual crab feed on June 17, 2017 at Burris Park and In-Home Supportive Services will hold their annual breakfast fundraiser on April 7, 2017.
