(Hanford City Council member, Justin Mendes was elected as the representative on the Board for 2016 and reappointed for 2017).

Appointment of (1) City representative to serve on the Kings County Consolidated Oversight Board. This will replace Redevelopment Agencies and Successor Oversight Boards. The State of California put an end to Redevelopment Agencies in 2012 and following that each City created a Successor Oversight Board. As of July 1, 2018 the four current RDA Oversight Boards will be replaced by one Countywide Oversight Board. The City Selection Committee has the responsibility of appointing one member to represent all cities in the County. This is a new appointment.
