Supervisor Fagundes stated that he was at the Central Coast last week for doctor appointments and vacation.

Supervisor Neves stated that he attended the renaming and dedication of Veteran's Park in Lemoore on July 4, 2019, he spoke on the earthquakes that affected the Ridgecrest area and stated that new information from emergency services is stating that everyone should have five days of supplies in case of emergency, dealt with a water main break in Stratford on July 10, 2019, thanked Supervisor Verboon and Julie Freitas for their help on the logistics for the Vice President Pence visit to Kings County on July 10, 2019, attended the Happy Together concert at Tachi Palace on July 10, 2019, attended the Agricultural Advisory Committee meeting and the Bird Street Brewing mixer in Lemoore July 11, 2019, acknowledged the Kings River Conservation District and United States Army Corps of Engineers for an outstanding job with water releases this year, attended the Cabrillo Club scholarship event on July 14, 2019 at Fraternal Hall and attended the Kings County Homelessness Collaborative meeting on July 15, 2019.
