On July 25, 2019 MicroFocus contacted Kings County to conduct formal license verification and compliance. As a result, the County worked with MicroFocus to complete a software audit. The audit identified additional licensing requirements, maintenance and fees, which this agenda item is designed to address. The licenses must be purchased from the manufacturer when discrepancies are found during an audit per our licensing agreement.

While the audit required an increased amount of licenses and maintenance to be purchased, staff was able to mitigate the cost increase by negotiating down the price with the vendor. This resulted in a cost savings to the County of approximately \$125,000. The licensing overage was largely due to the deployment of other software that proved to not be a viable alternative as well as increased program usage throughout the County. ITD is currently working to control cost increases for this software in the future. Primarily, ITD is investigating a new free version of the software available through the State. If this new version proves to be acceptable, staff will then remove licenses from any computers that no longer need the software. Our goal is to reduce licenses from this vendor as quickly as possible.

County Counsel has approved the terms of the quote as to form. The Purchasing Manager has reviewed and approved as to form the Sole Source purchase.

SUMMARY:

Overview:

The Master Fee Ordinance No. 520 was adopted in April 1993. Ordinance No. 520.21 was presented to your Board, and introduced on October 1, 2019 at a public hearing to include, remove, or increase certain fees that the County may collect. The ordinance is returned to your Board, and is presented for adoption.

Recommendation:

Waive the second reading and adopt Ordinance Number 520.21, the Master Fee Ordinance, including the Master Fee Schedule effective November 7, 2019.

Fiscal Impact:

The estimated fiscal impact is anticipated to be an increase of \$15,000 to the County's revenue for the remainder of Fiscal Year 2019-2020.

BACKGROUND:

The proposed ordinance, No. 520.21, and fee schedule were introduced at a public hearing on October 1, 2019. No verbal or written public testimony has been received as of the date of this Agenda Item's preparation. The fees associated with the ordinance and the removal of the Agricultural Commissioner/Sealer's fees will take effect no sooner than 30 days after adoption, which is November 7, 2019. This is pursuant to Government Code 66017. The Agricultural Commissioner/Sealer's fees will be established by resolution after the Ordinance's effective date. Attached to this agenda item is the final presentation of the schedule of fees that will be in effect upon adoption of the Master Fee Ordinance.

ORDINANCE NO. 520.21

AN ORDINANCE AMENDING ORDINANCE NO. 520.20 ESTABLISHING CERTAIN COUNTY FEES AND CHARGES AND ADOPTING A MASTER FEE SCHEDULE

The Board of Supervisors of the County of Kings ordains as follows:

SECTION 1. This Ordinance, its attachment, and all future amendments thereto shall be referred to and known as the "Master Fee Ordinance."

SECTION 2. The fees and charges set forth in the Master Fee Schedule, attached hereto and incorporated herein as though fully set forth, are hereby established for the following county departments, offices, and divisions thereof:

- a. Assessor/Clerk/Recorder
- b. Elections
- c. Board of Supervisors (Clerk of the Board)
- d. Community Development Agency
- e. District Attorney
- f. Finance Department
- g. Fire Department
- h. Health Department
- i. Library
- j. Minors Advocates
- k. Probation
- 1. Public Guardian
- m. Public Works
- n. Sheriff/Coroner/Public Administrator/Animal Control

SECTION 3. The fees and charges established herein shall take effect upon the effective date of this Ordinance.

SECTION 4. Fees and charges for the listed county departments, offices, and divisions thereof may be added, reduced, increased, or deleted from time to time by amendments to this Master Fee Ordinance in compliance with law.

SECTION 5. The fees and charges adopted in Section 2 of this Ordinance shall

supersede and take the place of any different fee or charge in any codified section of the Kings County Code of ordinances or in any resolution.

SECTION 6. The Kings County Board of Supervisors hereby adopts the following findings:

a. The Kings County Board of Supervisors held at least one public meeting at which oral or written presentations were made, as a part of a regularly scheduled meeting, and that notice of the time and place of the meeting, including a general explanation of the matter to be considered and a statement that the data required by this section is available, was mailed at least fourteen (14) days prior to the meeting to any interested party who filed a request with this Board for mailed notice of the meeting on renewed or increased fees or charges and; further, that at least ten (10) days prior to the meeting, this Board made available to the public data indicating the amount of the cost, or estimated cost, required to provide the service for which the fee is levied and the revenue sources anticipated to provide the service, including general fund revenues.

b. Prior to adopting this Ordinance, a public hearing was held at which oral or written presentations were made, and notice of the time and place, including a general explanation of the matter to be considered, was published in accordance with Government Code section 6062a.

c. The fees and charges specified by this Ordinance do not exceed the cost of providing the product or service or enforcing the regulation for which the fee or charge is levied.

SECTION 7. This ordinance shall take effect thirty (30) days after its adoption and before the expiration of fifteen (15) days after its passage and shall be published with the names of the members of the Board of Supervisors voting for and against the same in the Hanford Sentinel newspaper published in the County of Kings.

WHEREAS, LIH Oak Grove LP or a partnership of which LEDG Capital, LLC (the "Developer") or a related person to the Developer is the general partner, has requested that the California Public Finance Authority (the "Authority") adopt a plan of financing providing for the issuance of exempt facility bonds for a qualified residential rental project pursuant to Section 142(a)(7) of the Internal Revenue Code of 1986 (the "Code") in one or more series issued from time to time, including bonds issued to refund such exempt facility bonds in one or more series from time to time, and at no time to exceed \$22,000,000 in outstanding aggregate principal amount (the "Bonds"), to finance or refinance the acquisition, rehabilitation, improvement and equipping of a 81-unit multifamily rental housing project located at 1578 Grove Street, Healdsburg, California (the "Project"); and

WHEREAS, the Project is located within the City of Healdsburg; and

WHEREAS, the Authority is a joint powers authority created by the County of Kings (the "County") and the Housing Authority of Kings County and located in the County; and

WHEREAS, pursuant to Section 147(f) of the Code, the issuance of the Bonds by the Authority must be approved by the County; and

WHEREAS, the Board of Supervisors of the County (the "Board of Supervisors") is the elected legislative body of the County and is the applicable elected representative under Section 147(f) of the Code; and

WHEREAS, pursuant to Section 147(f) of the Code, the Board of Supervisors has, following notice duly given, held a public hearing regarding the issuance of the Bonds, and now desires to approve the issuance of the Bonds by the Authority; and

WHEREAS, the Board of Supervisors understands that its actions in holding this public hearing and in approving this Resolution do not obligate the County in any manner for payment of the principal, interest, fees or any other costs associated with the issuance of the Bonds, and said Board of Supervisors expressly conditions its approval of this Resolution on that understanding.

Section 1. The Board of Supervisors hereby approves the issuance of the Bonds by the Authority for the purposes of financing the Project. It is the purpose and intent of the Board of Supervisors that this Resolution constitute approval of the issuance of the Bonds by the Authority for the purpose of Section 147(f) of the Code by the applicable elected representative of the governmental unit having jurisdiction over the area in which the Authority is located.

<u>Section 2.</u> The officers of the Board of Supervisors are hereby authorized and directed, jointly and severally, to do any and all things and execute and deliver any and all documents, certificates and other instruments which they deem necessary or advisable in order to carry out, give effect to and comply with the terms and intent of this Resolution and the financing transaction approved hereby. Any actions heretofore taken by such officers are hereby ratified and approved.

<u>Section 3</u>. The Board of Supervisors expressly conditions its approval of this Resolution on its understanding that the County shall have no obligation whatsoever to pay any principal, interest, fees or any other costs associated with the Authority's issuance of the Loan for the financing of the Project.

<u>Section 4.</u> This Resolution shall take effect from and after its passage and approval.
