Declarations of Candidacy for eligible candidates desiring to file for any of the elective offices may be obtained by visiting the Kings County Elections Department website at CountyofKings.com/Elections. Candidates wishing to file for office must complete and submit a Candidate Documents Request to: Elections@CountyofKings.com. Elections Staff will process the request and a County of Kings Candidate Packet will be sent to the email address provided on the document request. Your County of Kings Candidate Packet will include the following forms: Declaration of Candidacy documents, Ballot Designation Worksheet, and FPPC Form 700. Declarations of Candidacy appointments shall be available commencing on July 13, 2020, and paperwork must be filed at the Elections Department in person no later than 5:00pm., August 7, 2020. Appointment to each elective office will be made as prescribed by Election Code 10515 in the event there are no nominees or an insufficient number of nominees for the office and a petition for an election is not filed with the elections official within the filing period.

Las declaraciones de candidatura para candidatos elegibles que deseen presentarse en cualquiera de los cargos electivos se pueden obtener visitando el sitio web del Departamento de Elecciones del Condado de Kings en CountyofKings.com/Elections. Los candidatos que deseen postularse para un cargo deben completar y enviar una Solicitud de documentos para candidatos a: Elections@CountyofKings.com. El personal de elecciones procesará la solicitud y se enviará un paquete de candidatos del condado de Kings a la dirección de correo electrónico que se proporciona en la solicitud del documento. El paquete de candidatos del condado de Kings incluirá los siguientes formularios: documentos de declaración de candidatura, hoja de trabajo de designación de boleta y formulario 700 de FPPC. Las declaraciones de los nombramientos de candidatura estarán disponibles a partir del 13 de julio de 2020, y deberán presentarse en persona en el Departamento de Elecciones a más tardar a las 5:00 p. m., 7 de agosto de 2020. La cita para cada cargo electivo se realizará según lo prescrito por el código electoral 10515 en caso de que no haya nominados o un número insuficiente de nominados para el cargo y no se solicite una elección archivado con el funcionario electoral dentro del periodo de archivo.
