COUNTY OF KINGS PUBLIC MEETING PROTOCOL IN RESPONSE TO CORONAVIRUS COVID-19

David Robinson, Kings County Sheriff stated that his staff has been working with Kings County Water District on homeless encampment and weed abatement issues on a property on 12th Avenue and Houston. He also stated that he has reached out to the City Police Departments in Kings County jurisdiction to discuss staffing assistance unilaterally in the case of COVID exposures.
