SUMMARY/BACKGROUND:

The Human Services Agency (HSA) is requesting to reflect a total available In-Home Supportive Services Public Authority (IHSS PA) spending for Fiscal Year (FY) 2021-2022 in the amount of \$469,612. The FY 2021-2022 appropriations and revenue in the amount of \$469,612 are based on the prior year State General Fund (SGF) allocation, Maintenance of Effort requirement, and federal Title XIX drawdown.

In addition to the FY 2021-2022 allocation, this budget also includes a sublease appropriation between IHSS PA and the Kings County Commission on Aging (KCCOA) in the amount of \$20,372 bringing the combined total to \$489,984. This sublease appropriation is a decrease from years past as the lease agreement will be ending October 31, 2021. The sublease and revenue amounts are reflected in the budget.

Claimed PA expenditures for FY 2017-2018 \$406,865, FY 2018-2019 \$406,048, FY 2019-2020 \$412,930, which is an average of \$408,614 each fiscal year. Upon approval of the budget, HSA will take agenda item to County Board of Supervisors to establish appropriations for individual accounts.

RECOMMENDATION: Approve the appropriations for the Human Services Agency In-Home Supportive Services Public Authority budget unit 510500 for Fiscal Year 2021-2022 in the amount of \$489,984.
