## PUBLIC MEETING PROTOCOL IN RESPONSE TO CORONAVIRUS COVID-19

California Governor Gavin Newsom issued Executive Orders N-25-20 and N-29-20 on March 12, 2020 and March 17, 2020, respectively, relating to the convening of public agency meetings in light of the COVID-19 pandemic.

Pursuant to the Executive Orders, and to maintain the orderly conduct of the meeting, the Public Health Department will allow the Collaborative members, county staff, and interested members of the public to attend the meeting telephonically or by the internet, and to participate in the meeting to the same extent as if they were present at the Homelessness Collaborative meeting. Members of the public who choose to attend the meeting virtually, using certain digital or landline phones, may listen to the audio broadcast of the meeting, but will not be able to comment during the meeting. Only those members of the public who cannot participate virtually due to a need for a special accommodation (vision, hearing, etc.) may attend the meeting at 711 W. Cinnamon Drive, Lemoore where efforts will be made to allow adequate social distancing and to ensure that exposed surfaces are sanitized. No more than 10 individuals will be allowed in the meeting room at a time. Members of the public who wish to participate in the meeting virtually can do so one of three ways: Via the worldwide web; by telephone; or by electronic mail. Public comment will be limited to three (3) minutes during the "Public Comment" section of the meeting. Public comment will not be available via phone.
