#### II. UNSCHEDULED APPEARANCES

Any person may directly address the Board at this time on any item on the agenda, or on any other items of interest to the public, that is within the subject matter jurisdiction of the Board. Two (2) minutes are allowed for each item.

Antony Lopez, Kings County resident stated that he is disappointed in the Boards decision to not adopt Public Map 101 and asked the Board to not adopt Public Map 120.

Lupe Chavez, Kings County resident stated that he has been speaking to residents in Avenal and that there were other maps the Board could have chosen and stated that he hopes that the Board approves a map to have two Latino majority districts.

Susan Ross, Kings County resident stated that Public Map 101 is fair and represents Kings County and asked the Board to try to be fair.

Barbara Castle, Kings County resident sated her concerns with the public not having an opportunity to review Public Map 120 and asked the Board to reconsider their decision and adopt Public Map 101.

Alvaro Preciado, Kings County resident stated that the citizens of Avenal are concerned about the changes that will happen over the next ten years and he doesn't see changes for the rural areas and sees trouble for the Board and that the rural areas need money for improvements for the residents and stated that Public Map 101 is equal for all residents.

Claire Fitiausi, Kings County resident stated that she has been paying attention to the redistricting process online since before the Board voted to hire National Demographic Corporation and has participated in each public hearing and was alarmed with the quick decision to adopt Public Map 120 when a resident of each of the Board members Districts have been present and spoke in support of Public Map 101 and the Board discounted their testimony and will be held accountable for their actions.

Ivette Chaidez, Kings County resident stated her outrage on the Boards decision to adopt Public Map 120 which is almost exactly like the current district boundaries and no public members attended and spoke up in support of that map at the public hearings and stated that this is why residents have to get involved in local government and asked the Board to do their jobs and represent the constituents they represent.

Cathleen Jorgensen, Kings County resident asked the Board to take the decision serious and be respectful to the public members who have spoken and stated that Public Map 120 was never discussed and questioned who submitted it and stated that it appears that South Hanford is craked with this map and stated that she doesn't feel her Supervisor cares about the residents.

Luis Huerta-Silva, Central Valley resident stated that he has been monitoring the Kings County Redistricting process and asked the Board to go above and beyond the law to make all information accessible and transparent for the public.
