#### III. UNSCHEDULED APPEARANCES

Any person may directly address the Board at this time on any item on the agenda, or on any other items of interest to the public, that is within the subject matter jurisdiction of the Board. Two (2) minutes are allowed for each item.

Ken Baird, Kings County resident shared a story regarding his son's mental health episode and how he has overcome and the need for affordable housing in Kings County.

Rose Shapley, Kings County resident stated that she submitted information on COVID to the Board and the dire need for everyone in the County to get vaccinated. She stated that she has drafted a solution to the floor plan of the proposed Northstar project to make sure that the property will have Amercians with Disabilities Act amenities.

Christine Leach, Kings County resident stated her concerns for the proposed residents to be placed in the Northstar property and shared her personal experiences with mental health patients as a registered nurse. She stated she is disappointed that the Board of Supervisors for not notifiying the residents near the project and for not protecting them and proposed the project be moved to the property proposed last week.

Anna Uribe, Kings In Home Supportive Services provider stated that she would like the Board to approve increased wages for IIHSS workers in Kings County.

Martha Valladarez, Kings In-Home Supportive Services provider and recent Vice-President of SEIU, shared what she does to care for her diabled daughter daily and asked the Board to approve a cost of living increase for IHSS workers in Kings County who do an important job for those in need.

Ernie Harmon, Kings County resident stated that the Board should spend time with the individuals who need help and will be in the proposed Northstar project and stated that the community should have known about the project prior to the approving the funding.

Rebecca Bell, Kings County resident stated that she spoke to the City of Hanford about the proposed property the public is referring to near the County Jail is medium density and not high density for the type of project like Northstar. She stated her concerns for the new residents of the facility from the uproar over the project and support of persons with mental illness.



Apolonia Arazate De Valencia, Kings In-Home Supportive Services provider stated that she would like the Board to approve wage increases for the IHSS workers in Kings County. She stated that the work is hard and 24 hours a day and they deserve to have better living wages.

Ernesto Reyes, Kings County resident stated that he would like the Board to approve higher wages for IHSS workers in Kings County and stated that there is a labor shortage and the IHSS workers are essential workers and do a job providing services to the most vulnerable in our community.

Lance Lippincott, Kings County Job Training Office Director stated that today the small business assistance program with \$157,000 available in \$2,500 increments to small businesses in Kings County who meet the criteria for the program. He stated that there will be two more programs by the end of the month and these programs will bring the total the Boad has made available for Kings County businesses to over \$7.5 million dollars in the past two years.

Supervisor Valle stated that he saw the post on the small business assistance program last week and asked for specific details on the current program and who it will help.

Lance Lippincott stated that the current program is a mico-enterprize loan and based on gross revenue and businesses in Kings County with five full-time equivalent employees or less. He stated that information will be sent out to the businesses that have expressed interest previously but did not qualify under the past programs.

Supervisor Verboon questioned whether the micro-enterprize program was a loan that had to be paid back.

Liz Toppan, Kings County resident asked for clarification regarding item VI.A. on the agenda today regarding Self-Help Enterprises agreement extension. She stated her concerns for the safety of the residents near the proposed Northstar project and what plans are place for dealing with incidents with the residents and the impact on the police department.

Chuck Kinney, Kings County Community Development Agency Director stated that the agreement is a long standing agreement with Self-Help Enterprises for the Community Devleopment Block grant program and First-time home buyers program in Kings County.

Chris Jordan, Kings County resident stated that the citizens are concerns for the Northstar project and not being given the opportunity to voice their concerns before the project was approved and questions posed by the public have not been answered. He stated that the members of the community have taken the time to come express their views and when is the Board going to answer their questions and allow the public to interact with the Board on the project.

Susan Long, Kings County resident stated that she is concerned that the public has not educated themselves on the type of residents that will be living in the proposed Northstar project and the lack of education to the public is a problem.

Susan Metz, Kings County resident stated that she moved to the north side of Kings County to have a safer environment for her family and the North star project will create an unsafe environment for the area.



Jeff Mora, Kings County resident stated that the Fire Department is seeking a ½% tax incentive and the IHSS workers are in need of higher wages and he knows that the Board has many issues they are dealing with but the location of the Northstar project is the problem for the citizens who have been coming to speak to at the meetings, not the need for a facility in the County.

# Questions about Northstar Court submitted by the community

Is it true no one can be denied housing in Northstar Courts if they are coming from an institution such as a mental health hospital, jail or prison?

- No one can be denied housing at Northstar Courts based solely on a previous incarceration or psychiatric hospitalization, however the Behavioral Health staff will be conducting an intake assessment to determine if an applicant is appropriate for this level of housing. If they require more intensive services and supports, such as our high-level ACT team for people who are not stable on medications, and not able to live independently, they will be referred to the appropriate level of care and housing.
- An applicant may be disqualified based on other factors such as criminal convictions related to housing and/or lack of income to pay rent.
- Community members who are required to register as sex offenders are not eligible to live at Northstar Courts.
- Northstar Courts is a permanent supportive housing property. It is not transitional housing (which is temporary, used for stabilization), it is not a homeless shelter and it is not a Board & Care or Room & Board such as are appropriate for conserved clients. There is no program at Northstar Courts that uses the property to house short-term residents and then transition out.
- All tenants with must complete an application and screening process that includes a background check, rental history, and verification of income. They must live independently, have their own income which they intend to use to pay rent, and they must sign their own lease and live by the conditions

of that lease. The credit and criminal history inquiries will be completed on each applicant (consistent with California law, specifically Welfare and Institutions Code Section 8255.)

Is it true that tenants will be accepted regardless of sobriety, participation in services or treatment, history of incarceration, credit history?

- Sobriety and participation in behavioral health services are not a condition of tenancy at Northstar Courts. However, illegal substances will <u>not be permitted</u> on site, and any reported usage will be investigated and result in a referral to a substance use disorder treatment program and/or eviction.
- The developer would be in violation of housing laws if they conditioned tenancy on sobriety. Drug and alcohol addictions are harmful to every sort of neighborhood but no type of housing can be based upon sobriety.
- Northstar Courts will provide services and programs for any tenant who would like help with addiction.
- The credit and criminal history inquiries will be completed on each applicant (consistent with California law, specifically Welfare and Institutions Code Section 8255.)

Is it true that once a person becomes a tenant of Northstar Courts they will not be required to be a client of the country behavioral health department or a recipient of mental health or other services to qualify or remain in an assisted unit?

• All outpatient behavioral healthcare is voluntary.

- Receiving mental healthcare (or other healthcare services) will not be required for tenants to remain housed. Requiring an individual to participate in services as a condition of their tenancy would be illegal.
- However, adhering to the terms of a lease, house rules, and payment of rent are required in order to remain at Northstar Courts

The Guiding Principles document from your website states that "we promote lease compliance" and "we encourage tenant responsibility" why are these things not a requirement of tenants?

- All tenants will be required to sign a lease and obey its terms and conditions.
- Each and every tenant at Northstar Courts will be bound to a legally enforceable lease. In the event a lease agreement is breached or violated, the property management and supportive staff will try to solve the problem and return to lease compliance. The partnership between Upholdings, Self Help and KCBH come into play in a situation like this. Every partner will be working to assist the tenant to help them come into compliance with their lease, and/or to get the assistance needed to do so. If needed, the client could be assisted in moving to a more supportive housing environment. (ACT, B&C, etc). If these efforts are not successful, the tenant can be evicted (post COVID restrictions which halted evictions).

Will Northstar Courts house only those from Kings County? If the answer is no, why are other counties allowed to place tenants out of county?

• Many tenants will find Northstar Courts on their own. No one will be placed at Northstar as it is independent housing. Local referrals will be

done through Kings County Behavioral health, community organizations and the property management staff marketing plans.

 Limiting leases to residents of Kings County would infringe on individual constitutional freedoms to move freely throughout the United States. However, it is expected that those who know about and hope to live in Northstar Courts will very likely be people who currently need housing in Kings County.

# What constitutes a service rich environment?

- Northstar Court's supportive services will include a Community Initiatives Manager from Self Help who will work on community building and connection to supportive services, and will include two fulltime staff who are employed by the County Behavioral Health Department. Supportive Services staff will each have an on-site office at Northstar Court and be available Monday – Friday from 8 am – 5 pm. Behavioral Health staff will include the following: one Recovery Support Coordinator (Case Manager) and one Peer Support Specialist.
- The team of supportive service providers will provide the follow types of services:
  - <u>Tenant Engagement</u> Supportive Services Staff and Property Management Staff will provide an orientation meeting for every new tenant, including an orientation to all onsite and offsite supportive services available. After the orientation meeting, engagement, focusing on developing relationships and trust will be provided to those individuals who initially decline services.
  - <u>Supportive Services</u> Creation and implementation of an Individual Service Plan/Wellness Plan; linkage to social services

including mental health treatment, substance use disorder treatment, co-occurring and primary care as needed; care coordination with resident and other service providers; linkage to educational opportunities, volunteer and job training opportunities; providing transportation or assistance in how to use transportations; linkage to social and recreational and volunteer activities; life skills support such as activities of daily living, cooking classes, housekeeping, budget/money management, laundry, cooking and meal preparation, shopping, financial literacy, basic nutrition, communication skills, and conflict resolution/mediation. Since service needs of residents are expected to fluctuate, each resident will be continuously assessed as to the type of service needed.

- <u>Coordination with property management</u> Property Management Staff and Supportive Services staff will work as a unified team and will meet weekly to support tenants to reach their goals. When behaviors or other challenges place a tenant at risk for eviction, Property Management Staff will immediately communicate with the Supportive Services Staff to support the tenant.
- Many services, including Behavioral Health and access to mainstream benefits through the Human Services Agency (SSI, Medi-Cal, etc) will be available to residents on-site. For off-site supportive services not provided at Northstar, KCBH and property management staff will support tenants by making transportation available to treatment appointments, recovery supports, outings and activities (additionally, Medi-Cal Managed Health Care plans provide transportation to appointment too). For tenants who would

like to use the public bus transportation, but who need support to do so, the supportive services staff will accompany the tenant for support and/or coaching until such time as that support is no longer needed or desired.

# What are the "house rules" that are listed on your bullet pointed fact sheet?

• The developers' property management company created the "house rules" many years ago to help communicate expectations to tenants. The house rules is a booklet and an addendum to the lease and explains to tenants property rules such as which type of satellite or BBQ they are allowed to use at the property. The "house rules" is a list of situations common to living at a multifamily property and is a tool for the property management company to maintain a clean and safe environment. The house rules for Northstar Court will be developed in collaboration with Self Help and KCBH.

Will afterschool services be provided for then entire community or only for residents?

- At this time the afterschool program services will only be provided to Northstar Courts residents. The developer has years of experience using services on and off their properties to benefit the community.
- Northstar Courts staff will constantly consider ways to provide more access for more services.

How will services be provided on-site with live in-service providers if only one unit is reserved for on-site services?

- Northstar Courts will not be a healthcare facility. It will not require 24/7 mental health or service staff to be on premises other than the property manager.
- The developer's properties are always adequately staffed to meet the needs of the property including compliance with state law for a residential unit.
- In addition to the onsite property manager, additional management staff including maintenance, janitors and service staff will also be onsite.
  California law requires that every apartment building with more than 16 units must have an on-site property manager. (California Code of Regulations, Title 25, section 42) An on-site property manager is a person who lives in a residential unit, such as an apartment unit in an apartment building. The developer will meet or exceed this requirement.
- Kings County Behavioral staff and Self Help will have its own staffing plans and will work them out together.

Is it true that your organization is not required to offer services for tenants suffering from co-occurring mental and physical disabilities, or co-occurring mental and substance abuse disorders?

• The Kings County Behavioral Health will provide supportive services to all tenants who are open to them including those with co-occurring disorders. These are mandated county behavioral health services which we would be providing to those who meet criteria in the community, regardless of where they live.

Additionally, I want to assure the Board that we will monitor and adhere to the requirements of the program and the contract. We expect excellence in our collaborative relationships. And we will work tirelessly to make Northstar Courts a success both for the residents and the community.
