Currently, there are extended wait times to access the established Veterans' Homes in the State for much-needed services. If veterans are unable to access Veteran Home services timely, they will have to seek other options, potentially out of the State of California or even risk becoming homeless. Veterans in need of skilled nursing and memory care must wait years before they get admitted. The construction of a new Veteran's Home in Monterey County would help to alleviate the long wait times and keep our veterans in the State. Current wait times for these services are:

- Yountville: five years wait time for admittance.
- West Los Angeles: two years wait time for admittance.
- Fresno: four years wait time for admittance.
- Redding: five years wait time for admittance.

California is losing veterans at an alarming rate – much faster than the next two largest veteran population states (Texas and Florida). We owe all we have to the veterans of this Nation, and it is our joint obligation to do all we can to care for those who have selflessly served for the freedoms we have today. Currently California veterans receive more than eight billion in Federal VA Compensation and Pension Payments. In addition, many receive Post 9/11 GI Bill, Chapter 33 Education Benefits and DoD Retirements. If Veterans leave the State so will the need for Veteran Serving organizations that create high paying jobs with the Federal VA, State, Counties, Private Sector, and Non-Profits that serve our veterans. Veterans positively impact the California Ecosystem.

The construction of a new Veteran's Home will lower or eliminate wait times for admittance into the CalVET Veteran's Homes for services including combined skilled nursing & memory care services.

Adding an additional Veteran's Home will increase the number of homes to nine in the State. Homes are available to disabled and aged veterans as well as spouses. This home will provide much needed care to our States' heroes and decrease the risk of these veterans becoming homeless. In addition, the location in Monterey County, will provide an attractive geographical location with a rich Military History and current Military presence. Residents of the Veteran's Home would have easy access to the Major General William H. Gourley VA-DoD Outpatient Clinic, Commissaries, Post Exchanges, Military Gyms, and other Military / Veteran accessible facilities. There are a large variety of beaches, walking / bike trails and County / State / National parks that will promote outdoor activity.

Additionally, Monterey County is interested in contributing land for a new CalVET Veteran's Home and Federal Grants are available for 65% of construction costs of the new Veteran's Home. In October 2018 an environmental group submitted a petition to the California Fish and Game Commission to list Crotch Bumble Bee, Franklin's Bumble Bee, Suckley Cuckoo Bumble Bee, and Western Bumble Bee for listing under the California Endangered Species Act (CESA). On December 9, 2022, the California Department of Fish and Wildlife (CDFW) opened public comment and data requests for the petition be submitted by January 15, 2023. Given the short amount of response time considering holiday closers and staff vacations a request for an extension of comment period to February 5, 2023, is being requested by multiple counties.

### **Recommendation:**

Authorize the Chairman to sign a letter requesting the California Department of Fish and Wildlife extend data and comment period to February 5, 2023.

### **Fiscal Impact:**

There is no fiscal impact to the General Fund.

### **BACKGROUND:**

In October 2018, an environmental group petitioned the California Fish and Game Commission to list the Crotch's, Franklin's, Suckley's cuckoo and western bumble bee species as Endangered under CESA. The Commission determined the listing "may be warranted" and the species became candidates for listing on June 12, 2019. That listing was legally challenged and the Sacramento based California Court of Appeal upheld the Commission's decision and candidacy was reinstated.

**RE:** Correction to Notice of Status Review for Bumblebee

To Whom It May Concern:

Due to varying considerations that have prevented a collaborative response, we respectfully request an extension to submit data and comments regarding the candidacy of the Crotch Bumble Bee, Franklin's Bumble Bee, Suckley Cuckoo Bumble Bee, and Western Bumble Bee for listing under the California Endangered Species Act (CESA) (Fish & G. Code, § 2074.4). The notice of status review was sent on Friday, December 9, 2022 with a deadline for receipt of comments by January 15, 2023. With holiday closures and staff vacations, a January 15, 2023 deadline for comment does not provide sufficient time to review and coordinate comments with our ag partners.

We believe this petitioned action is warranted and deserves careful review before a final determination is attained by the commission. We are requesting an extension of the comment deadline by three weeks, or February 5, 2023. As requested, we will utilize this time to closely review the information at our disposal regarding the general ecology of these species to effectively address all factors that may inhibit or impede the reproduction and survival of this varied but integral bumble bee population.

Thank you for your consideration in this matter as it has far-reaching implications not only for this agricultural region but to our respective counties and residents. We are hopeful that this request is granted and will be actively working on a response.
