**II. UNSCHEDULED APPEARANCES**

*Any person may directly address the Board at this time on any item on the agenda, or on any other items of interest to the public, that is within the subject matter jurisdiction of the Board. Two (2) minutes are allowed for each item.*

**Carolyn Leist, Human Resources Director stated that Melissa Avalos was promoted to Principal Analyst effective April 3, 2023 and wanted to introduce her the Board and congratulate her.**

**Phil Hansen, Kings County resident stated that #749 west is full and asked why the lowest elevations of the Lake Bottom are not being filled first and stated that he is concerned with Stratford and surrounding areas being flooded. He discussed levees cut during the 1983 floods along the Cousins, Brown and Lovelace canals. He asked why there were no elevations on the map that J.G. Boswell staff, Dominic Sween shared with the Board at the March 18, 2023 meeting.**

**Mike Ornellas, Vice President of the Kings County Firefighters Association recognized Dylan Vest , William Lynch, Josh Cunningham and former members who worked to get the \$4 million dollar grant for the Board to approve on the agenda today, which will go towards upgrades at the existing firehouses to help the department to better serve the communities where they are located. He thanked former Assemblymember Rudy Salas and Congresswoman Melissa Hurtado for procuring these funds and the previously approved \$1.5 million dollars for a total of \$5.5 million for the Department**

**Supervisor Valle recognized former Kings County Supervisor Craig Pedersen in the audience and stated that he was supportive of the project. He thanked J.G. Boswell representatives for coming to the meeting today and for meeting with Supervisor Neves and Supervisor Verboon and wanting to work with the County on the flooding issues. He stated that property owners in the flood area are not being notified and asked if the article he read regarding J.G. Boswell planting tomatoes in the lake bottom was correct and for the location of the tomatoes. He also read from a letter by George Wurzel to employees regarding the planting of tomatoes and other crops through the planting season and asked if the City of Corcoran was in any danger of being flooded.**

**Mark Unruh, J.G. Boswell representative explained the elevations in the Lovelace area and stated that the Lovelace is the next lowest spot for flood water. He stated that the article Supervisor Valle is referring to has false information as to the location of the tomatoes and was not aware of future crop plans.**

**George Wurzel, J.G. Boswell stated that the company is planting tomatoes in Kern County on higher ground and stated that there are fewer plants than they had planned due to flooding. He stated that the neighbor was planting tomatoes and discussed that they are planting above the levee's and stated that J.G. Boswell is planning for Kern River water to be placed in the Cousins area and stated that they are trying to work with the County, but 1 million acre feet of water, can't be mitigated and stated that the levees need to be elevated to save the City of Corcoran and the State Prison facility. He stated that they have been working with their staff on the issues. He stated that the cutting of #749 took the mitigation out of their hands and he asked to have the Hansen family move dirt to allow the J.G. Boswell company to use the gates for Lovelace before it impacts everyone.**

**Supervisor Valle asked the J.G. Boswell representatives to work with the staff in the County Office of Emergency Services to help mitigate the impacts and to be more transparent moving forward to raise awareness versus immediate responses.**
