II. UNSCHEDULED APPEARANCES

Any person may directly address the Board at this time on any item on the agenda, or on any other items of interest to the public, that is within the subject matter jurisdiction of the Board. Two (2) minutes are allowed for each item.

Chase Nunes, Kings County resident/Hanford High School student stated that he has been invited to play with the Greater Fresno Boys Baseball team and accompany them to Toyohashi Japan for three weeks to play baseball at the 39th annual World Boys Baseball tournament. He stated that he is the only Kings County player on the team and that he will have a drive through Pulled Pork fundraiser dinner to help pay for his trip and expenses on June 25, 2023 at the Laton Lions Hall and tickets are \$20 each and he has left some tickets with the Clerk of the Board if anyone wishes to purchase them.

Sarah Hacker, Kings County District Attorney stated that on June 8, 2023 operation "Movin' Out" was conducted in Kings County by the Task Force and 62 arrests were made including suspects for three homicide cases. She stated that the District Attorney's office now has to prosecute all of the defendants and asked the Board to look at using American Rescue Plan Act funding for signing bonuses and retention pay. She stated that she is looking at contacting independent contract attorneys to help with the caseload.

Maria Hoover, Administration/Minors Advocates Division stated that her office has been trying to recruit for one position since December 2022 and that Tulare County pays \$20,000 more to start than Kings County and stated that her staff has been able to recover \$691,000 out of \$791,000 available from the courts and with another position she thinks all of the funding could be recovered and asked the Board to look at using ARPA funding to increase the starting pay and signing bonuses.

Lupe Villa, Kings County Registrar of Voters stated that the notice of a public hearing to consider draft election administration plan and receive public comment pursuant to California Elections Code Section 4005 (a)(10)(D)(i) and the deadline is June 27, 2023. He stated that the Draft Renewal Election Administration Plan 2023 is posted on the Elections website at wwww.votekingscounty.com and posted to their social media platforms.
