

#### SIGNING AND STRIPING GENERAL NOTES

- 1. TRAFFIC SIGNING AND STRIPING, AND THE INSTALLATION THEREOF SHALL CONFORM TO CALTRANS LATEST REVISED STANDARD PLANS AND SPECIFICATIONS, DATED 2022, THE 2014 CALIFORNIA MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES (CA MUTCD), LATEST EDITION, THIS PLAN AND THE SPECIAL PROVISIONS. THE CONTRACTOR SHALL VERIFY THE INFORMATION SHOWN ON THESE PLANS WITH THE REFERENCED DOCUMENTS AND NOTIFY THE COUNTY OF KINGS OF ANY DISCREPANCIES 48-HOURS PRIOR TO COMMENCING WORK.
- 2. ALL CONFLICTING TRAFFIC LINES AND PAVEMENT MARKINGS SHALL BE COMPLETELY REMOVED BY LIGHTLY GRINDING, PLACE TYPE I SLURRY SEAL UPON AFFECTED AREA.
- 3. DEPRESSIONS IN THE PAVEMENT RESULTING FROM THE REMOVAL OF RAISED PAVEMENT MARKERS SHALL BE PATCHED AS NECESSARY TO MATCH THE SURROUNDING SURFACES.
- 4. ALL PAVEMENT MARKINGS (EXCEPT WHERE NOTED OTHERWISE), STRIPING, AND CROSSWALKS, SHALL BE PAINT. REFER TO SPECIFICATIONS.
- 5. CONTRACTOR TO FURNISH AND INSTALL NEW SIGNS, POSTS AND NEW STREET NAME SIGNS, AS NOTED. NEW SIGNS SHALL BE HIGH INTENSITY PRISMATIC SHEETING. NEW SIGN SIZE SHALL MATCH EXISTING.
- 6. ALL NEW SIGN POSTS SHALL BE SQUARE STEEL TUBING WITH METAL DRIVE ANCHORS (2-1/2" SQUARE UNISTRUT TELESPAR TUBING OR APPROVED EQUAL).
- 7. ALL SALVAGED SIGN EQUIPMENT SHALL BE DELIVERED TO THE COUNTY OF KINGS.







#### **GENERAL NOTES**

- 1. ALL IMPROVEMENTS SHALL BE AS PER CURRENT COUNTY OF KINGS ENGINEERING IMPROVEMENT STANDARDS & SPECIFICATIONS AND THE LATEST REVISED 2022 EDITION OF THE STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION STANDARD PLANS & SPECIFICATIONS.
- 2. THE CONTRACTORS SHALL BE LICENSED AS A CLASS "A" GENERAL ENGINEERING CONTRACTOR AND ALL SUB-CONTRACTORS SHALL POSSESS THE APPROPRIATE CLASS "B" OR "C" OR OTHER SPECIALTY LICENSE AS REQUIRED BY THE CATEGORY OF WORK TO BE PERFORMED IN ACCORDANCE WITH THE PROVISIONS OF CHAPTER 9, DIVISION 3 OF THE BUSINESS AND PROFESSIONS CODE.
- 3. THE CONTRACTOR SHALL IMMEDIATELY NOTIFY THE ENGINEER OF ANY AND ALL CONFLICTS BETWEEN CONTRACT DOCUMENTS AND THE ACTUAL SITE CONDITIONS PRIOR TO COMMENCING WORK IN ANY GIVEN AREA AND ALLOW TIME FOR THE ENGINEER TO ISSUE RESOLUTION TO ANY PROPOSED CONFLICTS. THE CONTRACTOR SHALL CONTINUE WORK IN OTHER AREAS OF THE PROJECT WITHOUT SUCH CONFLICTS UNTIL THE ENGINEER HAS ISSUES RESOLUTION BY CHANGE ORDER OR OTHER PROJECT APPROVED LINES OF COMMUNICATION.
- 4. SHOULD IT APPEAR THAT THE WORK TO BE DONE OR ANY MATTER RELATIVE HERETO IS NOT SUFFICIENTLY DETAILED OR EXPLAINED ON THESE PLANS, THE CONTRACTOR SHALL CONTACT THE COUNTY OF KINGS AT (559) 852-2601 FOR SUCH FURTHER EXPLANATIONS AS MAY BE NECESSARY.
- 5. UNAUTHORIZED CHANGES AND USES: THE ENGINEER PREPARING THESE PLANS SHALL NOT BE RESPONSIBLE FOR, OR LIABLE FOR, UNAUTHORIZED CHANGES TO OR USES OF THESE PLANS BY OTHERS. THE CONTRACTOR SHALL SUBMIT TO THE ENGINEER ANY PROPOSED MODIFICATIONS AND/OR CHANGES TO THE PLANS AND SPECIFICATIONS IN WRITING WITH SUFFICIENT DETAILED INFORMATION AND TIME TO ALLOW THE ENGINEER TO CONDUCT AN ANALYSIS OF THE PROPOSED CHANGE AND PREPARE A WRITTEN RESPONSE TO THE CONTRACTOR. APPROVED CHANGES AND/OR MODIFICATIONS TO THE PLANS AND SPECIFICATIONS SHALL BE ISSUES BY THE ENGINEER AS CHANGE ORDERS.
- 6. THESE PLANS ARE THE PROPERTY AND COPYRIGHT OF THE ENGINEER AND SHALL NOT BE USED ON ANY OTHER WORK EXCEPT BY WRITTEN AGREEMENT WITH THE ENGINEER. WRITTEN DIMENSIONS SHALL TAKE PRECEDENCE OVER SCALED DIMENSIONS AND FIELD DIMENSIONS SHALL BE VERIFIED ON THE JOB SITE. ANY DISCREPANCY SHALL BE BROUGHT TO THE ATTENTION OF THE ENGINEER PRIOR TO THE START OF ANY WORK.
- 7. CONTRACTOR SHALL PROVIDE PEDESTRIAN, VEHICLE, WORKER AND TREE PROTECTION AS NECESSARY FOR THE FULL DURATION OF THE PROJECT.
- 8. CONTRACTOR SHALL INSTALL APPROVED TRAFFIC CONTROL SIGNS PRIOR TO COMMENCEMENT OF ANY WORK INCLUDING ALL LIGHTS, SIGNS, BARRICADES, FLAGMEN OR OTHER DEVICES NECESSARY TO PROVIDE FOR SAFETY.
- 9. CONTRACTOR SHALL MAINTAIN DUST CONTROL ABOUT THE SITE OF WORK. THE CONTRACTOR SHALL BE RESPONSIBLE FOR ANY DAMAGE OR OTHER CONSEQUENCES RESULTING FROM HIS FAILURE TO DO SO.
- 10. CONTRACTOR SHALL NOTIFY THE APPROPRIATE AGENCY AT LEAST 10 WORKING DAYS PRIOR TO COMMENCING WORK SO THAT SAID AGENCY MAY PRESERVE SURVEY MONUMENTS AND BENCHMARKS, WHICH MAY NOT BE DISTURBED WITHOUT AGENCY CONSENT. THE CONTRACTOR SHALL BE RESPONSIBLE FOR REPLACING DESTROYED BENCHMARKS AND SURVEY MONUMENTS. THIS WORK SHALL BE DONE UNDER THE SUPERVISION OF A LICENSED SURVEYOR.
- 11. CONTRACTOR SHALL PRESERVE ALL CONSTRUCTION SURVEY STAKES AND PROPERTY LINE MARKERS WHEN REASONABLY POSSIBLE. ANY STAKES OR MARKERS REQUIRING REPLACEMENT BY THE ENGINEER SHALL BE DONE AS "EXTRA WORK."
- 12. CONTRACTOR IS RESPONSIBLE FOR OBTAINING ALL PERMITS & INSPECTIONS. ANY INSPECTION TO BE PERFORMED BY THE COUNTY SHALL REQUIRE A 48-HOUR NOTICE.
- 13. CONTRACTOR SHALL NOTIFY THE APPROPRIATE PERMIT AGENCY AT LEAST 10 WORKING DAYS PRIOR TO COMMENCING WORK AND SHALL CONDUCT ALL WORK IN ACCORDANCE WITH THE PERMITS AND/OR SPECIAL CONDITIONS AS ISSUED BY THE AGENCY OR UTILITY COMPANY INVOLVED.
- 14. CONTRACTOR SHALL NOTIFY ENGINEER 3 WORKING DAYS (MIN.) PRIOR TO WORK REQUIRING STAKING FOR PROPER SCHEDULING.
- 15. EXISTING UNDERGROUND UTILITIES AND IMPROVEMENTS ARE SHOWN IN THEIR APPROXIMATE LOCATIONS BASED UPON RECORD INFORMATION AVAILABLE TO THE ENGINEER AT THE TIME OF PREPARATION OF THESE PLANS. LOCATIONS MAY NOT HAVE BEEN VERIFIED IN THE FIELD AND NO GUARANTEE IS MADE AS TO THE ACCURACY OR COMPLETENESS OF THE INFORMATION SHOWN.
- 16. THE CONTRACTOR SHALL NOTIFY THE OWNER & UTILITY COMPANIES AT LEAST 2 WORKINGS DAYS IN ADVANCE OF CONSTRUCTION TO FIELD LOCATED UTILITIES. CALL "UNDERGROUND SERVICE ALERT" (U.S.A.) AT 1-800-227-2600 OR 811. IT SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR TO DETERMINE THE EXISTENCE AND LOCATION OF THOSE UTILITIES SHOWN ON THESE PLANS OR INDICATED IN THE FIELD BY LOCATION SERVICES. ANY ADDITIONAL COSTS INCURRED AS A RESULT OF THE CONTRACTOR'S FAILURE TO VERIFY LOCATIONS OF EXISTING UTILITIES PRIOR TO BEGINNING OF CONSTRUCTION IN THEIR VICINITY SHALL BE BORNE BY THE CONTRACTOR AND ASSUMED INCLUDED AND MERGED IN THE CONTRACT UNIT PRICE.




