DEPOSITS/PAYMENTS: Are applied to the contract and fees will be deducted from it. Contracts that exceed the deposit must be kept in paid status. Any remaining deposit will be refunded within **7-10 BUSINESS DAYS** after the bin is received and contracted job is complete. If charges for the contract exceeded the deposit, final payment is due within **15 CALENDAR DAYS** of when the bin is received by KWRA. **FAILURE TO PAY WILL RESULT IN DEFAULT STATUS AND YOUR CONTRACT WILL BE REFERRED TO THE DISTRICT ATTORNEY'S OFFICE FOR COLLECTION** _____(INITIAL)

TERMS: Your rental period is for fourteen (14) days, beginning on the day of delivery. You will be charged \$25 per day for each sequential day you retain the bin. _____(INITIAL)

WEIGHT: Bins cannot exceed 7-10 tons maximum weight, depending on the size of the bin. Any bin that is unable to be moved must have material removed by YOU. KWRA will not remove or assist in any way. If there is debris sticking out of the bin or doors are not closed at the time of retrieval, driver will charge a \$50 fee and not retrieve your bin until corrections have been made. _____(INITIAL)

You are responsible for contacting KWRA when the bin is ready to be dumped, returned to you, or your contracted job is complete. Please call **(559) 583-8829** to be placed on the pick up schedule. **YOU MUST PROVIDE YOUR CONTRACT NUMBER IN ORDER TO BE PLACED ON THE SCHEDULE.** Staff will not place you on the schedule without it. _____(INITIAL)

YOU ARE NOT TO DISPOSE OF ANY LIQUID WASTE, HEAVY INERT MATERIAL (CONCRETE OR DIRT) OR HAZARDOUS WASTE AND NO TREATED WOOD. KWRA WILL RETURN ANY TREATED WOOD WASTE TO YOUR PROPERTY. VIOLATION OF KWRA POLICY WILL RESULT IN PENALTIES AND/OR CHARGES FOR DAMAGES ADDED TO YOUR BILL _____(INITIAL)

PROPERTY DAMAGES: KWRA WILL NOT BE RESPONSIBLE FOR DAMAGES TO ANY PROPERTY FROM PLACEMENT OF BIN. CHARGES WILL BE ASSESSED TO ANY DAMAGE DONE TO KWRA ROLL OFF BIN. _____(INITIAL)
