UNSCHEDULED VACANCY NOTICE

NOTICE IS HERBY GIVEN that the Local Agency Formation Commission (LAFCo) is seeking applications to fill vacancies for the following: One (1) Primary Public Member and One (1) Alternate Public Member.

Appointments are for four (4) years unless the position is filling an un-expired term. The Primary Public member's term ends on May 1, 2027 and the Alternate Public member's term ends on May 1, 2025. *Both appointments will be considered by the existing four (4) members: two (2) City members and (2) Board of Supervisors representatives acting in their capacity as the Local Agency Formation Commission members at regularly scheduled meeting anytime after October 4, 2023. The Board of Supervisors will not be considering these appointments.*

Membership Composition:

The complete membership of the Committee consists of five (5) regular members and three (3) specific alternates: two (2) City representatives and one (1) alternate, two (2) Board of Supervisors representatives and one (1) alternate, one (1) primary public member representing the County at large and one (1) alternate.

***The two (2) Board of Supervisor representatives and one (1) alternate representative are appointed by the Board of Supervisors**

****The two (2) City members and one (1) alternate member are appointed by the City Selection Committee**

*****The two (2) Public members: one (1) Primary Public member and one (1) alternate are appointed by the LAFCo existing seated Commission members**

The Commission meets at 1:00 p.m. on the fourth Wednesday of each month in the Hanford Civic Auditorium, 400 N. Douty Street in Hanford.

The purpose of the Commission is to discourage urban sprawl and encourage orderly formation and development of local government agencies.

The purpose of this notice is to give any individual the opportunity to apply as well as any special interest group the opportunity to submit names of individuals to be considered for appointment.
