Dear all.

Yesterday, your Board took action to provide retention pay in the amount of \$10,000 to Safety employees over the next 2 years. I feel compelled to speak out.

Firstly, I am here to advocate on behalf of all Blue Collar Workers who are not deemed "safety" from the County's perspective.

I will provide you with some response examples:

- Road emergencies such as flooding, car accidents, road closures, etc.
- Building Maintenance and Central Plant responds to calls at the Government Center, the Jail, Probation, Jail, A/C, building emergencies.
- Janitorial staff: Do you realize that many of the County's services would not be able to continue during Covid if they were not there to respond?
- Our Fleet Division keeps Sheriff and Roads running so they can respond.

These are all emergency safety responses! Our Blue Collar workers are some of the hardest working individuals and some of the lowest paid. Some opt out of the County health plan because they cannot afford it. Some are medi-cal eligible. What does that tell you? I respectfully request you recognize them as safety and extend the same bonuses to them.

Additionally, as a Kings County employee, please give the same incentive for those who have been long-standing, dedicated employees with several years of service. Why don't you give back to those who have been the backbone of this county with longevity pay? I have seen other government do this. We are worthy! We have a vested interest in this County and there are not many of us left anymore. Thank you for the 1.5% raise but giving bonuses to only safety employees (and especially to those who are just hired), feels like a slap in the face. Your Board should know the general consensus among employees.

Please recognize and reward us with longevity pay in the same amount. Thank you for your time and consideration. Please note: I will be in person to read this aloud (and to be on record) during unscheduled appearances at your next regularly scheduled Board meeting.
