Jason Kemp Van Ee, Social Services Program Manager in the Human Services Agency, provided IHSS Spring Newsletter. Jason reported that at the onset of possible flooding in Corcoran, Wellness Calls were made to IHSS recipients. Staff identified that 568 Corcoran residents and 75 Stratford residents would need assistance to evacuate. Also, State has provided funding for a Career Pathways Program. In order to assist providers in obtaining training, we worked with a non-profit who has a contract with CDSS to provide training and were able to bring them to Kings County. They did CPR, first aid, body mechanics, heavy transfers, mechanical lifts, and personal care for a consumer confined to a bed training. We had 40 providers participate.

Wendy Osikafo, Executive Director of Public Authority, is preparing to amend the County Ordinance to hold the Public Authority Board meeting quarterly.

## **SUMMARY:**

## Overview:

The Kings County In-Home Supportive Services (IHSS) Public Authority (PA) is requesting approval to increase the IHSS PA Fiscal Year (FY) 2023-24 Adopted Budget.

## Recommendation:

Increase the appropriations for the Human Services Agency In-Home Supportive Services Public Authority budget unit 510500 for Fiscal Year 2023-24 from \$532,436 to \$545,608.

## Fiscal Impact:

The increase in allocation will be budgeted in budget unit 510500. All costs associated with this program will be offset with state general fund allocation and Title XIX federal funds. There is no impact to the County General Fund with the recommended action.

## **BACKGROUND:**

On August 8, 2023, the County Board of Supervisors approved to establish appropriations and revenues for IHSS PA budget unit 510500. The appropriations and revenue were approved in the amount of \$532,436 based on the prior year SGF allocation and federal Title XIX drawndown. Since the adoption of the budget in August, County Fiscal Letter (CFL) 23/24-14 was released, which included additional State General Fund (SGF) for the Public Authority Administration in the amount of \$6,586. When matched with Federal funds, this allocation will increase the funding in the amount
