#### II. UNSCHEDULED APPEARANCES

Red Fitiausi, Hanford High School student stated that she would like to see the Board hold a meeting once a month at 6:00 p.m. so that she and others can be involved. She also asked to have unscheduled appearances moved to the end of the agenda to allow for public to speak on the items they are interested in. She also stated that it is wrong that the Kings County Firefighters Association has been without a contract since June 30, 2023.

Trent James, Kings County Deputy Sheriff's Association member stated that they have been without a contract since June 30, 2023, and stated that they have been in impasse through the negotiation process and the salary survey should be accessible.

Jonathan Brewster, Kings County Deputy Sheriff's Association member stated that he is here to represent over 90 law enforcement personnel who work to keep Kings County safe and stated that they are the first called when help is needed by other jurisdictions. They have a good culture in their office and are still losing deputies to other jurisdictions for pay because they are being aggressively recruited and using an out of date survey is not worth the money and not being given the information which was paid for by public funds is keeping them from getting a fair share and he asked the Board to help them in the negotiations and follow the impasse process.

Carolyn Leist, Human Resources Department Director stated that staff met with the Deputy Sheriff's Association yesterday and will be discussing the details in closed session with the Board today.

Supervisor Verboon stated that the Board will be discussing the status of the negotiations for all bargaining units and thanked everyone for their attendance today and stated that the Board is listening to all of the requests.
