Declarations of Candidacy for eligible candidates desiring to file for any of the elective offices may be obtained from the Kings County Elections Department, at 1400 W Lacey Blvd, Hanford, CA 93230. Declarations of Candidacy shall be available commencing on July 15, 2024, and shall be filed at the Elections Department in person no later than 5:00 p.m., August 9, 2024. Appointment to each elective office will be made as prescribed by Section 10515 (10229 for cities) in the event there are no nominees or an insufficient number of nominees for the office and a petition for an election is not filed with the elections official within the time period prescribed by Section 10515 (10229 for cities).

La designación de cada oficina electiva se realizara según lo prescrito por la Sección 10515 (para las ciudades) en caso de que no haya nominados o un numero insuficiente de candidatos para la oficina y una petición para una elección no se archiva con el oficial de la elección dentro del periodo de tiempo prescrito por la Sección 10515 (para las ciudades).
