#### II. <u>UNSCHEDULED APPEARANCES</u>

Any person may directly address the Board at this time on any item on the agenda, or on any other item of interest to the public, that is within the subject matter jurisdiction of the Board. Two (2) minutes are allowed for each item.

Chief Flores, Kings County Fire Chief, provided an update to the Board on the current extreme heatwave and information on cooling centers as well as personnel deployments on out of county fires.

Natalie Brinson, Kings County Parks & Grounds Superintendent, stated that she took personal time off to come here to speak on behalf of the employees in her division to support their request for increased salaries and gave statistical data information on what surrounding counties are paying employees with the same jobs.

Anthony Atilano, Kings County Parks & Grounds worker, stated that he has worked for Kings County for 20 years and he has seen many good employees leave for higher salaries and the cost-of-living increases have forced many of his coworkers to seek second jobs to be able to support their households and asked the Board to look at increasing wages for their positions.

Eric Archuleta, Kings County Parks & Grounds worker, stated that he has worked for Kings County for 10 years and asked the Board to consider wage increases for workers in his division.

Chris Williams, Kings County Parks & Grounds worker, read information into the record on behalf of Kings County Parks & Grounds worker Josh Fraijo asking the Board to consider increased wages for the lowest and overlooked employees of the County.

Red Fitiausi, Valley Voices representative, stated that are 10,404 youth between the ages of 14-18 in Kings County and she would like to request more free activities and events. She stated that she is also in support of item IV.A.1 from Child Support Services and would like to see that become a permanent option.

Melissa Ramirez, Kings County resident, stated that she was here on behalf of neighbors in the Home Garden area where travel trailers and motor homes have moved into private property and along streets. She stated that she met with Supervisor Valle and County staff to look at solutions for the safety and health concerns of the residents in the area.

Sarah Hacker, Kings County District Attorney, stated that she would like the Board to reconsider the salaries of the attorneys in her office and stated that she is unable to fill positions and gave an update on outreach she has done to recruit and her concerns for prosecuting crimes in the future.

Matt Sanfilippo, Kings County Battalion Chief, thanked the Board for supporting the Kings County Firefighters and acknowledging their union.

Supervisor Valle thanked the residents of Home Garden that attended the meeting today and stated that he met with them prior to the meeting this morning and feels that the County staff involved will help with their concerns and get them some help.
