Supervisor Valle presented a certificate and gifts to Kirsten Robinson.

Duane Cooper, Kings County Roads Superintendent, stated that he is here today on behalf of his staff and requested that the Board consider a pay raise and longevity pay for them. He said that many new staff get trained and licensed while here in the County and then leave for better pay.

Robert Angel, Road Maintenance Worker, stated he was here on his own time to express his concern regarding the current salary survey and the unfair salary negotiations. He stated many of his peers have multiple jobs due to the current cost of living. He asked the Board to consider higher wages as he and his co-workers put their lives in danger every day performing their job duties and expressed seeing many co-workers leave over the years once they have been trained and get their licenses to other jobs that pay higher wages.

Eduardo Oquita, Road Maintenance Worker and SEIU Member, stated he was here before the Board today to speak on behalf of the Blue-Collar Union and requested the Board to consider wage increases and to work with their union to meet this goal and he expressed his concern for the retention issues their current wages cause.

Carolyn Leist, Human Resources Director, introduced Jessica Cervantes, Human Resources Technician, she stated that Jessica previously worked for the Human Resources Department. Jessica stated that she was happy to be back working at the County.

Sarah Hacker, Kings County District Attorney, stated that she was here to speak on behalf of all county employees and the dissatisfaction of the current salary survey and requested the Board to consider higher wages for all employees and rejecting the salary survery. She expressed her concern over the inaccuracies of the survey and the high cost of the survey and to please consider putting investing money in our employees.
