PUBLICATION NOTICE OF SPECIAL BOND ELECTIONS AND NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS FOR TULARE JOINT UNION HIGH SCHOOL DISTRICT
NOTICE IS HEREBY GIVEN to the qualified electors of the Tulare Joint Union High School District (the "District") located in the County of Tulare, State of California, that in accordance with the provisions of the Education Code of the State of California, an election will be held on November 5, 2024 within the School District, at which election the following measures shall be submitted to the qualified electors of the District and voted upon:
Tulare Joint Union High School District
"To improve the quality of education; make health, safety and security improvements; upgrade HVAC systems; and construct/ renovate/modernize classrooms, restrooms and school facilities; shall Tulare Joint Union High School District's measure authorizing \$80,000,000 of bonds at legal rates be adopted, generating an average \$5,400,000 annually, at average rates of approximately \$29 per \$100,000 assessed value, while bonds are outstanding, with annual audits, citizens' oversight, all money staying local, with no protected increase to existing tax rates?"

The above proposition shall become effective if 55% of the votes cast approve the proposition. All of the purposes enumerated in the foregoing measure shall be unified and voted upon as one single measure, with precincts, places or holding the elections and officers appointed to conduct the elections to be the same as those provided for the General Election to be held on November 5, 2024. The bonds proposed to be issued and sold shall bear interest at a rate not exceeding twelve percent (12%) per annum. The number of years for which the bonds are to run shall not exceed the greater of the term of the bonds to be issued or the term of the bonds to be issued under the authority of the Education Code and forty (40) years in the case of bonds issued under the authority of the Government Code, from the date of the bonds or the date of any series thereof. This election has been called pursuant to a Resolution of the Governing Board of the Tulare Joint Union High School District, adopted on June 13, 2024.

The Elections Official of the County of Tulare hereby gives formal notice of the election in accordance with the provisions of Education Code Section 15120. Arguments for or against this measure may be submitted to the Tulare County Registrar of Voters Office, 5300 W. Tulare Avenue, Suite 105, Visalia, CA 93277 no later than July 18, 2024, which has been determined by the elections official to be a reasonable date based upon the time necessary to prepare and print arguments. No argument shall exceed 300 words in length. Pursuant to Section 9501 of the Elections Code, one argument for and one argument against this measure will be selected for printing and distribution to the voters with the Voter Information Guide. The elections official will also provide opportunity for rebuttal arguments to be filed no later than July 28, 2024, in accordance with Section 9504 of the Elections Code. For more information on filing arguments, call the Registrar of Voters Office, (559) 839-2100. The polls will be open Election Day between 7:00 a.m. and 8:00 p.m.
