PLANNING COMMISSION

One (1) vacancy currently exists on this Commission for a representative of Supervisorial District No. 2. Appointments are for four (4) years unless the position is filling an unexpired term. This vacancy has a term expiring on June 30, 2028 and applicants must reside within the Supervisorial District in which the vacancy occurs. Members are appointed by the Board of Supervisors pursuant to Chapter 19 of the Kings County Code of Ordinances.

The purpose of this Commission shall be to develop and maintain the County General Plan, develop such specific plans as may be necessary and/or desirable; to periodically review the capital improvement program of the County, and perform such other functions as the legislative body may provide.
