Mr. Ference inquired if the 218 Election was on the Board of Supervisor's agenda for the next week and if the Commission could make a recommendation on how the Board of Supervisor's should vote, to which Mr. Kinney confirmed. Mr. Cooper provided comments on the 218 Election. Mr. Gilcrease commented on the assessment and creation of the fees. Mr. Adams explained the item being on the Board of Supervisors' agenda. Mr. Prys expressed concern for the landowners' input in the decisions. Mr. Gilcrease expressed concern about the amount of the fees. Mr. Cooper stated the fees are necessary but needs more assessment. Mr. Ference asked for clarity on how the recommendation will be provided to the Board of Supervisors. Mr. Kinney provided explanation. Mr. Gilcrease commented on more support from the Board of Supervisors in relation to the 218 Election.

A motion was made and seconded (Gilcrease/Cooper) to recommend the Board of Supervisors to vote no on the land and water fees associated with Proposition 218 Election. Motion carries with four in favor and two absent (Belezzuoli-Hathaway, Draxler).
