
To whom it may concern:

My name is Laura Gallardo and I live at the Kings County Housing Authority.

For more than a year, I have request assistance from the Kings County Supervisor Richard Valle. I have sent him and email on 07/22/24. No response. I explained to him the abuse occurring and the threats. I have items that have not been fix for over a year. I have asked for help due to Administrative Sandra Jackson Bobo making threats towards me with her connections with the corcoran mayor and district attorneys office. I complained how an officer from the district attorneys office pretended to be the administrative supervisor and was listening to my confidential information. How do I know? I just had a meeting with the administrator and supervisor at administration office. I complained about Sandra allowing for the Corcoran police department to illegally take my confidential chart. That is a crime. Per Kathy Reynoso, the manager just handed over my chart twice to the police department without legal paperwork. I have gone thru Cancer treatment and this causes excessive stress. I will be sending some examples.

2. I wrote an email to Kyria Martinez on 07/12/24 and she refused to assist me with a complaint. She clearly stated her office doesn't handle complaints. I have been there to the office and it was always an issue. Who handles these complains?
