COUNTY CLERK'S REPORT

In accordance with Section 17081 of the California Election Code, I Joan L. Bullock, as County Clerk, hereby report that on April 11, 1990, I conducted the official canvass of the returns of said elections, including Measure "A", The Pioneer Union School Special Bond Election, Measure "B", The City of Hanford Special Annexation Election (Kings Road), and Measure "C", The Stratford Irrigation District Special Election and at-large election of their board of directors held on the 10th day of April, 1990. Pioneer School Special Election consisted of 1 voting precinct with absentee ballots. The City of Hanford Special Annexation Election and the Stratford Irrigation District Special Election were conducted by all mail ballots. The total vote cast for each candidate and measure is the same on the tabulated statements attached and the totals shown are full, true and correct.
