COUNTY CLERK'S REPORT

I, Joan L. Bullock as County Clerk and Ex-officio Clerk of the Board of Supervisors, hereby report that on September 13, 1979 I conducted the canvass of the returns of the Special Avenal Incorporation Election and that the total votes cast in said election in Kings County, including 59 absent voters' ballots was 771 out of 1,155 registered voters in the proposed boundaries of the proposed city of Avenal. Total percentage of possible voter participation was 66.75%. The total vote cast for and against each measure and for each candidate is the same as appears on the tabulated statement attached.


