I, Joan L. Bullock as County Clerk and Ex-officio Clerk of the Board of Supervisors, hereby reprot that on March 8, 1979, I conducted the canvass of the returns of the Special Reef-Sunset Union School Unification Measure and Governing Board Member Election and that the total votes cast in said election in Kings County, including 7 absent voters' ballots was 539 out of 1,338 registered voters in the district for a 40.28% turnout. The total vote cast for and against the unification measure and for each candidate is the same as appears on the tabulated statement attached.
